

Enbridge Home Energy Conservation Program

Now more customers than ever before can qualify for **thousands** in available incentives from Enbridge Gas on their home renovation projects.

- Complete a minimum of **two upgrades and achieve a minimum of 10% Natural Gas savings**
- Home must be heated with natural gas
- Each Service Organization provides the same customer experience and will be able to facilitate the rebate on the customer's behalf. Upon successful completion of the program, Enbridge Gas will include a \$550 reimbursement on the customer's final incentive cheque to offset the cost of both energy assessments.
- Maximum total Enbridge Gas rebate is \$5,000**
- All work and final assessment must be completed within **120 days of initial assessment**
- In order to qualify for incentives, initial and final assessments must take place prior to December 31st, 2019

Enbridge Gas Incentives: at least two of these upgrades must be undertaken to qualify for incentives

Air Sealing

- \$100** • For reaching target on report
- \$150** • For reaching 10% above target on report
Baseline calculation is done during the initial assessment

Attic Insulation

- \$500** • For increasing attic insulation to at least R50 from R12 or less
- \$250** • For increasing attic insulation to at least R50 from R13 to R25
- \$500** • For increasing cathedral/flat roof insulation by at least R14

Basement Insulation

If less than 100% is completed the incentive will be pro-rated.

- \$1,000** • For adding at least R23 to 100% of basement
- \$500** • For adding at least R12 to 100% of basement
- \$800** • For adding at least R23 to 100% of crawl space wall
- \$400** • For adding at least R10 to 100% of crawl space wall
- \$450** • For adding at least R24 to 100% of floor above crawl space

Exterior Wall Insulation

If less than 100% is completed the incentive will be pro-rated.

- \$1,500** • Add at least R9 for 100% of building to achieve a minimum of R12
- \$1,000** • Add at least R3.8 for 100% of building to achieve a minimum of R12

Furnace/Boiler*

*Combi unit will only count as one measure

- \$750** • FURNACE: replace a furnace that is less than 95% efficiency with a furnace that is 95% AFUE or higher
- BOILER: replace a boiler that is less than 90% efficiency with a 90% AFUE or higher ENERGY STAR® condensing boiler

Water Heater

- \$200** • For replacing existing natural gas water heater with 0.80 EF or higher **tank type**
- For replacing existing natural gas water heater with 0.82 EF or higher **tankless type**

Window/Door/Skylight

- \$40** • For each window, door or skylight replaced with an ENERGY STAR® Certified model

ADDITIONAL BONUS INCENTIVES: available for deeper energy savings as part of the maximum \$5,000 Enbridge Gas Incentives

- Install 3 upgrades** - customer will receive additional **\$250**
- Install 4 upgrades** - customer will receive additional **\$500**
- Install 5 upgrades** - customer will receive additional **\$750**

To qualify for the Home Energy Conservation Program, homeowners must also agree not to participate in any other gas or building envelope program(s) offered by parties outside of Enbridge Gas Inc. between the initial and final assessments.

Program is effective to December 31st, 2019. Natural gas fuel savings are based on approved modeling software. Only one enrollment for incentive per household is permitted. To find out if you qualify for incentives, an initial and final home energy assessment is required by a Program approved Registered Energy Advisor (REA). No more than 120 days between the assessments is allowed. If more time is needed to complete your upgrades, simply speak with your REA and they can request an extension. Please contact one of the Enbridge approved Service Organizations listed at enbridgesmartsavings.com for further information about this Program. The Home Energy Conservation Program is only available for residential detached homes, row towns and semis – no multi-residential buildings or condos.
